He brings nearly two decades of actuarial and analyst experience across the insurance and finance sectors, including at Bank of America and Standard Life. He is a Fellow of the Institute and Faculty of Actuaries.

Both Emma and Andy start in their roles at the end of January 2026.

António Simões, Chief Executive Officer at Legal & General, said: "We are making strong progress towards our vision for a growing, simpler and better-connected business. These appointments will play an important role in driving and executing the next phase of our strategy.
